CONTINUATION ORDER

WHEREAS, the recognition u/s 14(3)(a) of NCTE Act, 1993 was granted to the institution namely **Indhira College of Education, Pandur, Thiruvallur Taluk, District-631203, Tamilnadu** vide order No. F. TN/SEC/SRO/NCTE/2005-2006/4195 dated 02.09.2005 for conducting **Secondary (B.Ed.) Course** of one-year duration with an annual intake of 100 students from the academic session 2006-07.

2. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 02.03.2015 for its willingness & adherence of provisions of new Regulations. A Revised Provisional Recognition Order (RPRO) was issued to the institution on 12.05.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.

3. **AND WHEREAS**, the SRC in its 369th meeting held on 28.01.2019 has considered the matter and decided to issue a Show Cause notice. Accordingly, a Show Cause Notice was issued to the institution on 21.02.2019. The management of the institution vide letter dated 13.03.2019 & 24.08.2019 respectively has submitted a replies in response to the Show Cause Notice.

4. **AND WHEREAS**, the SRC in its 380th meeting held on 18th – 19th September 2019 has considered the matter and decided to issue a Final Show Cause Notice. Accordingly, a Final Show Cause Notice was issued to the institution on 26.09.2019. The management of the institution vide letter dated 29.10.2019 has submitted a reply in response to the Final Show Cause Notice.

5. **AND WHEREAS**, the SRC in its 405th meeting held on 13th -14th December, 2021 has considered the matter and decided to withdraw the recognition of the institution. Accordingly, Withdrawal Order No.SRO/NCTE/APS06342/B.Ed./TN /2021/129838 was issued to the institution on 07.01.2022.

6. **AND WHEREAS**, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-175/E-258506/2022 Appeal/8th Meeting, 2022 Appeal No.APPLSRC202214307(B.Ed.) and Order No.89-176/E-258506/2022 Appeal/8th Meeting, 2022 Appeal No.APPLSRC202214308 (M.Ed.) dated 16.11.2022 appeal remand back the order

11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution:
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last, quarter:
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

12. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

13. The institution shall make available the list of students admitted on its official website.

14. The institution shall fill the information on GIS Portal on the NCTE Website.


