I am to inform you that the authorities have considered your request to grant affiliation for starting of self-financing Education College in the name and style of "Indhira College of Education, Pandur, Thiruvallur Dist - 631 203" to offer B.Ed. Degree course for the academic year 2006-2007 with the students strength of 100, based on the 1) recognition from the NCTE; 2) direction of the High Court, Chennai; 3) the report of Inspection Commission, headed by Dr.D.Kumaran, Prof. & Head, Dept. of Education, University of Madras, Chennai and 4) the compliance report of your Management and decided to grant provisional affiliation for the academic year 2006-2007, pending approval of the Syndicate and subject to fulfillment of the following conditions:-

- (i) the conditions stipulated by the Inspection Commission in its report of inspection;
- (ii) all the conditions laid down by the N.C.T.E., Bangalore;
- (iii) other usual conditions of affiliation (copy enclosed);
- (iv) the candidates so admitted in B.Ed., Degree course should earn necessary attendance prescribed by the University for appearing the University examinations.;
- (v) the teachers should be paid salary as per the pay scales of U.G.C. and their salaries should be paid through Bank, by name Cheque only;

- (vi) steps should be taken by the Management of the Indira Educational & Charitable Trust to shift the College to the permanent site before the commencement of the next academic year

I am, further, to inform you that an application for continuation of provisional affiliation for the above course for the next academic year 2007-2008 should be sent, immediately along with the extension approval accorded by the NCTE for 2007-2008.

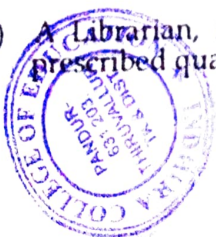

CONDITIONS OF AFFILIATION

- 1) The College shall implement each and every one of the recommendations of the Inspection Commission;
- 2) The Class room shall be according to the norms suggested by the UGC/NCTE;
- 3) The Library should be strengthened, as suggested by the Inspection Commission. The Library shall have common reading room and stock room as per standard prescribed by the U.G.C./State Government/NCTE. The Library should be kept open from 8 a.m. to 8 p.m. on all working days;
- 4) The Maximum number of students who may be admitted to the course shall not exceed the strength sanctioned by the NCTE/University;
- 5) Laboratory shall be strengthened, as suggested by the Commission. The Laboratory shall have sufficient equipments required for performing experiments prescribed for the courses of study. The laboratories shall also have adequate arrangement for gas supply, regular water supply and electricity. The safety standard shall be fully observed;
- 6) Necessary Hostel accommodation, Staff Quarters, Play-ground are to be provided;
- 7) Arrangements shall be made by the College for the conduct of University Examinations;
- 8) No donations shall be collected from the students seeking admission to this course of study in the College;
- 9) Excess admission shall never be made to the course over and above to the sanctioned strength;
- 10) The Management of the College shall not discontinue the course without prior permission from the University which should be intimated before the 30th September.
- 11) The College shall only collect Tuition and other fees from the students at the rates as prescribed by the State Government/University;
- 12) In the interest of standard of P.G. Education, the guidelines prescribed by the University for the P.G. Courses shall be followed. The admission to P.G. Courses will be considered on the guidelines determined by the Syndicate from time to time;
- 13) The guidelines with regard to infrastructure required for conducting the Computer Science Subject, if any, and qualification for the Teaching staff should be strictly adhered to;
- 14) The College should have (1) Separate Lounge (2) Rest Room (3) Toilet (4) Women Faculty Room, etc.,
- 15) A Librarian, Physical Director/Directress and a Medical Officer with the prescribed qualification shall be appointed.

- 16) Number of teaching and non-teaching staff shall be appointed as per norms prescribed by the University/ U.G.C./ Government / NCTE for the course including foundation course, allied and application oriented subjects, if any;
- 17) No teacher shall be appointed, if he/she has not fulfilled the qualifications as laid down by the University and UGC/NCTE, from time to time;
- 18) Teaching and Non-teaching staff shall be paid as per pay scales of State Government/U.G.C prescribed, from time to time;
- 19) An agreement shall be entered into with each teacher to be appointed as per the requirements of the University /Tamilnadu Private Colleges (Regulation) Act and rules thereunder;
- 20) The posts of teacher and Head of Departments wherever required for the proposed course shall be filled up before starting the course;
- 21) No teacher shall be appointed or shall be continued in service, who has attained the age of superannuation as may be prescribed by the Tamilnadu Government;



Ref: NCTE Letter D.O.No.49-4/2010/PT/NCTE/N&S, dated 30.07.2010.

I am to state that the National Council for Teacher Education in the letter cited, has informed that taking cognizance of the shortage of trained teacher educators in teacher education institutions in the country, it has decided to enhance the intake capacity of one unit of M.Ed Degree course from the existing 25 students to 35 students from the current academic year 2010-2011.

The Syndicate of this University considered the above subject matter at its meeting held on 10.08.2010 and resolved that in accordance with the amendment conveyed by the National Council for Teachers Education, New Delhi in the Letter No.F.No.49-4/2010/PT/NCTE (N&S), dated 30.07.2010 the increase in M.Ed admission from the existing 25 to 35 from the academic year 2010-2011 be approved and implemented with due communication to the colleges offering M.Ed Degree Course affiliated to this University.

In accordance with the above resolution of the Syndicate and the decision of the National Council for Teacher Education, I am, by direction, to state that the colleges offering M.Ed Degree Course affiliated to this University may increase the students admission strength to M.Ed Degree course from the existing 25 students to 35 students from the academic year 2010-2011.
