WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014

2. AND WHEREAS, the institution, Indhira College of Education, Pandur, Thiruvallur Taluk & District-631203, Tamilnadu has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed which require additional facilities.

3. AND WHEREAS, on scrutiny it is found that the institution has not shifted to its own premises as stipulated in its Formal Recognition order dated 22.11.2005.

4. AND WHEREAS, the SRC has decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely.

- I. The institution shall submit all documents including land, building, Encumbrance Certificate, Land Use Certificate, Building Plan, approved staff list, pertaining to shifting to own premises to the SRC before 31st July, 2015 failing which recognition will be withdrawn.
- II. The Regional Committees shall inspect the proposed premises during August-September-October, 2015 and if on inspection it is found that the institution does not fulfil required norms of infrastructure recognition will be withdrawn.
- III. Further, with regard to the second unit the institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- IV. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available otherwise it can also be given to the Visiting team at the time of inspection.
- V. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.

5. NOW THEREFORE, in the light of the above and in terms of Section 14(3) of NCTE Act and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby grants recognition to Indhira College of Education, Pandur, Thiruvallur Taluk & District-631203, Tamilnadu for conducting B.Ed programme of two years duration with an annual intake of 100 students each for two basic units from the academic session 2015-16 subject to fulfilment of the conditions mentioned at 4.(i) and 4.(ii) herein before 31st July, 2015 and those mentioned at 4.(iii), 4.(iv) before 31.10.2015.

2. AND WHEREAS, the institution, Indhira College of Education, Pandur, Thiruvallur Taluk & District, Tamilnadu has by affidavit consented to come under New Regulations and sought for one unit in M.Ed, which requires additional facilities

3. AND WHEREAS, on scrutiny it is found that the institution has not shifted to its own premises as stipulated in its Formal Recognition order dated 06.05.2008.

4. AND WHEREAS, it has been decided to permit the institution an intake of one unit of 50 students subject to the institution fulfilling following conditions namely,

WHEREAS, the recognition was granted to the institution namely, **Indhira College of Education, Pandur, Thiruvallur Taluk & District, Tamilnadu** run by **Indira Educational & Charitable Trust, Thiruvallur District, Tamilnadu** vide SRC vide order no. F.SRO/NCTE/M.Ed./2007-2008/1512 dt. 06.05.2008 for conducting **M.Ed.** course of one-year duration with an annual intake of 25 students.

2. **AND WHEREAS**, the enhancement of intake of 10 seats from existing 25 to 35 is permitted to **Indhira College of Education, Pandur, Thiruvallur Taluk & District, Tamilnadu** vide order No. F.SRO/NCTE/2010-2011/20584 dt. 23.08.2010 from the session 2010-2011.

3. **AND WHEREAS**, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 02.03.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 22.05.2015 for conducting **M.Ed. programme** of two years duration with an annual intake of 50 students (one unit) from the academic session 2015-2016.


4. **AND WHEREAS**, the SRC in its 369th meeting held on 28.01.2019 has considered the matter and decided to issue Show Cause Notice. Accordingly, a Show Cause Notice was issued to the institution on 21.02.2019. The institution has submitted reply on 01.03.2019 & 13.03.2019.

5. **AND WHEREAS**, the SRC in its 405th Meeting held on 13th & 14th December 2021 considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

The institution was issued a Final Show Cause Notice (FSCN). The institution has submitted its reply vide letter dated 29.10.2019. The Committee observed the reply submitted by the institution and found the following deficiencies.

1. The institution submitted a copy of letter dt. 09.12.2016 regarding approval of 13 faculties for B.Ed. course issued by the Registrar, TTEU. The institution also submitted copy of letters dt. 16.09.2017 and 02.12.2016 issued by the Registrar, TTEU regarding approval of Principal and 7 Assistant Professors for M.Ed. course.

The institution did not submit latest approval of affiliating University for B.Ed. and M.Ed. courses.

The faculty strength is not enough for both B.Ed. and M.Ed. courses as required under Appendix 4 and 5 of NCTE Regulations, 2014.

The institution did not submit approval of affiliating body regarding faculty for D.El.Ed. course.

2. The institution submitted Encumbrance Certificate but the same belongs to "House Site" and "Agricultural Land". This is not permissible under rules.
3. The institution has submitted certified/notarised copy of the Lease deed.
4. The institution is required to submit an attested/notarized copy of Land Use Certificate issued by the Competent Authority.
5. The institution submitted copy of building plan but shown the amenities only for B.Ed. course in which multi-purpose hall area is not sufficient as per NCTE Norms. The institution did not submit building plan showing all facilities for M.Ed. and D.El.Ed. courses with demarcated built-up area for all the courses being run in the premise.
6. The institution has not submitted a notarised/attested copy of Site Plan approved by the Competent Authority.
7. The institution has submitted a photocopy of BCC has submitted which is not legible as per NCTE Regulations.
8. The institution did not submit proof of disbursement of salary to faculty & non-teaching staff through bank account as required under clause 10(2) of NCTE Regulations, 2014.
9. The institution has not submitted a "Form A" issued by the **respective Bank Manager** towards creation of FDR of Rs.7 lakh and 5 lakh, totalling Rs.12 lakh along with copy of FDRs.
10. The institution did not submit details of administrative and professional staff as required under clause 5.3 of Appendix 4 and 5 of of NCTE Regulations, 2014.
11. The website of the institution is not uploaded with the information required under clauses 7(14)(i), 8(14) and 10(3) of NCTE Regulations, 2014.
12. The institution did not submit registration certificate, bye laws etc. related to the managing society / trust.

Hence, the Committee decided to **withdraw the recognition** granted to **Indhira College of Education, Pandur, Thiruvallur Taluk, District-631203, TamilNadu** for conducting **B.Ed., M.Ed. & D.T.Ed. / D.El.Ed.** programme with effect from the academic session i.e., 2022-2023 onwards under clause 17(1) of NCTE Act, 1993 on the grounds mentioned above."

6. **NOW THEREFORE**, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition granted to **Indhira College of Education, Pandur, Thiruvallur Taluk, District-631203, TamilNadu** for conducting **M.Ed. programme** of two years duration with an annual intake of **50 students (1 basic unit)** with effect from the academic session i.e., 2022-2023 onwards.

8. Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.



The application submitted by **Indhira College of Education, Thiruvallur District** together with the report of the Inspection Commission has been considered by the Syndicate on 08.10.2021 and passed orders to grant continuation of provisional affiliation to Indhira College of Education to offer B.Ed degree programme for three academic years from 2021-2022 to 2023-2024 subject to the condition of retifying following deficiencies and submission of relavant requiried documents by the Management of the College of Education within six months.

1. Building License issued by Tahsildar for current period.
2. Land Use Certificate from Collector / Tahsildar
3. Encumbrance Certificate for Land
4. Qualification approval of the 2 teachers are not available.
5. Last three months' Salary of the faculty through ECS (Electronic Clearing System) for B.Ed degree programme.
6. Land Area, whether Wet or Dry Land (Wet Land Conversion Certificate issued by Directorate of Town and Country Planning in case if it is Wet Land as per the new Section 47(A) in the Tamil Nadu Town and Country Planning Act 1971, vide notification in the Tamil Nadu Government Gazette dated 01.01.2011 is not furnished.
7. Certificate under Section 37(B) of Tamil Nadu Land Reforms (Land fixation and Ceiling) Act 1961, vide notification in the Tamil Nadu Government Gazette dated 10.06.2010 is not furnished.

8. Documentary evidence for payment of Infrastructure and amenity charges as per Tamil Nadu Gazette Notification regarding Levy of Infrastructure and Amenities Charges Rules 2008, vide notification in the Tamil Nadu Government Gazette dated 26.01.2008.

Resolved further that the affiliation be cancelled, if the Management of the College of Education is not able to rectify all the deficiencies pointed out in the affiliation order within six months.

The conditions laid down by this University for affiliation are furnished below which the College should strictly adhere to and any lapse will attract suspension of affiliation as per the Statute No. 6(iii) and Chapter XIII of Tamil Nadu Teachers Education University.

The Following Conditions shall be strictly adhered to.

1. All the conditions laid down by the NCTE, SRC, New Delhi.
2. Candidates to be admitted in B.Ed. Degree course shall (a) satisfy the eligibility conditions prescribed in the Regulations and the guidelines issued by the Government of Tamil Nadu for the academic year 2021-2022 (b) obtain approval from the University for the students admitted to B.Ed. degree course as per prescribed norms and (c) earn required attendance prescribed by the University for appearing for the University Examinations.
3. The admission of students for B.Ed. Degree Course shall be made in accordance with the guidelines for admission prescribed by the Government of Tamil Nadu and the regulations of the University for each academic year. No student shall be admitted with irregular attendance. No ratification will be considered for any such irregular admission.
4. The Syllabus prescribed by the Tamil Nadu Teachers Education University shall be followed.
5. The college shall complete 200 working days as prescribed by the NCTE / University in its Regulations prescribed for B.Ed. course in an academic year.
6. Arrangement shall be made by the college for the conduct of University Examinations.
7. No donations shall be collected from the students seeking admission to any course of study in the college.
8. The college shall only collect Tuition and other fees from the students at the rates as prescribed by the State Government / University. If any College found collecting more and above the fee fixed by the Government of Tamil Nadu, the affiliation of the College will be withdrawn.

9. The Management of College shall not discontinue any existing course without prior permission from the University which should be intimated before the 30th September of the respective academic year.
10. A Librarian and Physical Director/Directress with the prescribed qualification shall be appointed.
11. Number of teaching and non-teaching staff shall be appointed as per norms prescribed by the University/ U.G.C./NCTE/Government for each course. The post of Principal shall not be kept vacant and qualified Principal shall always be in position.
12. No teacher shall be appointed, if he/ she has not fulfilled the qualifications as laid down by the University and U.G.C./NCTE from time to time.
13. An agreement shall be entered into with each teacher to be appointed as per the requirements of the University/ Tamil Nadu Private Colleges (Regulation). Act and rules there under.
14. The Professor should be paid as per pay scales of UGC/NCTE/VI pay commission of the State Government, as the case may be, and their salary should be paid through Electronic Clearing System (ECS). This will be verified by the authorities from time to time.
15. The posts of Professor and Head of the Departments wherever required for the proposed course shall be filled up before starting the course.
16. No teacher shall be appointed or shall be continued in service, who has attained the age of superannuation as may be prescribed by the Tamil Nadu Government.
17. Suitable leave rules for teaching and Non-teaching staff shall be framed, generally in conformity with the State Government rules.
18. Approval shall be obtained from the University before appointing the teaching staff.
19. The College shall implement each and every recommendations of the Inspection commission.
20. The College shall have [1] Separate lounge [2] Rest room [3] Toilet for Women Faculty.
21. The classrooms shall be according to the specification of the U.G.C./NCTE norms.
22. The library should be strengthened, as suggested by the Inspection commission. The library shall have common reading room and stack room as per standard prescribed by the U.G.C. /NCTE/ Government.
23. Land Use Certificate, Land Continuity Certificate and Land Classification Certificate obtained from the competent authorities shall be kept ready for verification at any time.

24. Fire Service Certificate shall be obtained and renewed and shall be kept ready for verification at any time.
25. The Laboratory shall have sufficient equipments required for performing experiments prescribed for the courses of study. The laboratories shall also have adequate arrangement for gas supply, regular water supply and electricity. The safety standard shall be fully observed.
26. The required area of land and the building shall be in the name of the Trust.
27. The College shall obtain Building Plan approval and License from the competent authorities for constructions.
28. The maximum number of students who may be admitted to each of the course shall not exceed the strength sanctioned (100) by the NCTE / University.
29. Necessary Hostel accommodation, Staff quarters, Play ground shall be provided.
30. Such other Rules and Regulations as may be generally prescribed from time to time by the University shall also be abided by the Management.
31. All the conditions shall be abided by the Management and in the event of any violation, the affiliation granted shall be ceased automatically.
32. As per the "National Council for Teacher Education, (Recognition Norms and Procedures Amendment)" Regulations December 2014, an institution shall be permitted to apply for new courses listed in the regulations. Institutions offering teacher education programmes for a minimum period of five academic years, being affiliated to a University, and having applied for accreditation from NAAC or any other accrediting agency approved by NCTE is eligible to apply M.Ed. programme.
33. The attendance of the staff members and the students shall be effectively monitored and periodical report shall be submitted by post/online every day.
34. The Institution should submit the name list of students admitted along with the Medium of Instruction opted by each student i.e. English or Tamil (as per the availability of Medium of Instruction in the College of Education) to the University.
35. The institution shall maintain & update its Web-site as per the provisions of NCTE Regulations and always display following as mandatory disclosure:
 - i. Sanctioned programmes along with annual intake in the institution.
 - ii. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - iii. Names of faculty members who left or joined during the last, quarter:
 - iv. Names of students admitted during the current session along with qualification, percentage of marks in the qualifying examination and in the entrance test, if any, date of admission etc.,

- v. Fee charged from students.
- vi. Available infrastructural facilities.
- vii. Facilities added during the last quarter.
- viii. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- ix. The institution shall be free to post additional relevant information, if it so desires, and
- x. Any wrong or incomplete information on website shall render the institution liable for withdrawal of recognition.

While communicating the above decision, I am to request you to kindly forward a specific and detailed report in this regard, immediately after fulfilling all the above conditions of affiliation.

The Management has to apply for Continuation of Provisional Affiliation for the three academic years 2024-2025 to 2026-2027 for which the Management shall submit the prescribed application on or before 31.10.2023 along with the registration fee and processing fee as prescribed by the University.
